# Introduction and Background

Over the last several decades, the State of Indiana has committed to collecting supplemental information from health professionals through survey questions administered during online license renewal. The collection of supplemental information, such as practice location and future employment plans, from health professionals during license renewal is a best practice for informing health workforce planning.<sup>1</sup> This data has been used to inform various initiatives, including identification of health workforce shortages (such as federal Health Professional Shortage Area designations)<sup>2</sup>, health workforce incentive programs (such as State Loan Repayment Program),<sup>3,4</sup> Medicaid provider analysis and recruitment,<sup>5</sup> Indiana Primary Care Needs Assessments<sup>6</sup>, and various technical reports and policy briefs on Indiana's health professionals<sup>7</sup>.

Until 2019, the survey questions collecting supplemental information from health professionals during the biennial license renewal process were voluntary, limiting the representation in reported responses. In 2018, Senate Enrolled Act 223<sup>8</sup> transitioned collection of specified supplemental information from voluntary to mandatory for licensees of selected health professional boards. These requirements help to ensure an accurate and comprehensive representation of actively practicing health professionals in Indiana. Below is an outline of the information required to be provided by licensees, and the health professional boards that are included in this requirement.

#### *Information required to be provided by health professionals:*

- The practitioner's specialty or field of practice.
- Information concerning the practitioner's current practice:
  - o The location or address.
  - o The setting type.
  - o The average hours worked weekly.
  - o The health care services provided.
- The practitioner's educational and training background
- For a practitioner that is a prescriber (as defined in IC 25-1-9.5-4), whether the practitioner delivers health care services through telehealth (as defined in IC 25-1-9.5-6).

#### *Boards Affected by SEA 223-2018:*

- Medical Licensing Board
- Indiana State Board of Nursing
- State Board of Dentistry
- Behavioral Health and Human Services Licensing Board
- State Psychology Board
- Indiana Board of Pharmacy

Within SEA 223-2018, legislation outlined that the information collected in this law must be compiled in an annual report. This report serves to fulfill that requirement and aggregate information and resources on Indiana's health workforce to enhance accessibility and utilization of this information.

# Supplemental Information on Indiana’s Health Workforce, by License Type

The following sections of this report summarize supplemental information collected in accordance with Senate Enrolled Act 223-2018, including: educational characteristics, specialty, telehealth, and services provided. Professionals included in these sections renew their licenses on a biennial basis, and as such, supplemental information are updated biennially. Supplemental information is presented for licenses included in SEA 223-2018. Additional information on other license types may be available upon request from the General Assembly or a state agency.

This report has been structured for biennial reporting and as such includes shell tables where additional information will be incorporated once it is available for reporting.
